

J&K Police as Dy. Superintendent of Police on April 20, 2011. He did his basic training in Sher-i-Kashmir Police Academy Udhampur (SKPAU) from April 20, 2011 to May 31, 2012. After successful completion of his basic training DySP Aman Kumar was posted in District Bandipora in June 2012 where he served up to January, 2014. At the time of withdrawal of force in the area near Chee Gali militants fired indiscriminately upon deployed nafri with the intension to kill them. The fire was retaliated to culminate the Meanwhile militants. more reinforcement of territorial SDPO / SHO / DOs rushed onspot immediately. In the ensuing fire fight, 05 CRPF personnel laid down their lives and SHO Police Station Anantnag Mr. Arashad Khan Inspector among a civilian girl and other 05 security personnel sustained bullet injuries. All the injured were shifted to District Hospital Janglaat Mandi Anantnag for treatment where from the injured girl after first-aid was discharged and other injured persons evacuated to 92 Base hospital Badami Bagh Srinagar for further treatment. In the firefight, a terrorist also got eliminated. In this regard a case FIR No 105/ 2019 U/s 307, 302 RPC 7/27 A/act stand registered. The seriously injured inspector Arshad Khan was later on referred to SKIMS Soura for further treatment and subsequently he was air lifted to AIIMS Delhi on June 16, 2019 for further specialized treatment but unfortunately he succumbed to his injuries in the AIIMS on the same day i.e 16 June, 2019.

Martyr Inspector Arshad Khan is survived by his wife Mrs Neelofar Bashir and two minor sons four year old Uhbaan khan and eighteen months old Damin Khan besides his parents and brother Rashad Khan.

Hon'ble Home Minister of India Shri Amit Shah accompanied by senior officers visited the house of Martyr Inspector Arshad Khan at Balgarden, Srinagar on June 27, 2019 to offer his condolences to the bereaved family. He met Martyr Arshad's parents, wife, brother and children. While consoling

the bereaved family on the occasion Hon'ble Home Minister said that the sacrifices of the martyr Inspector Arshad Khan for the security of our nation has saved many lives and entire Nation is proud of his valor and courage. Hon'ble Home Minister asked administration to ensure that memorials are built for the Martyr Police men in their home towns and villages besides naming prominent public places after the Martyr Police men.

Earlier, when the body of Martyr Inspector Arshad Khan, who was injured in a militant attack in Anantnag on June 12, 2019 and later succumbed to his injuries at AIIMS New Delhi on June 16, 2019, a wreath laying ceremony was held at District Police Line in Srinagar. Advisors to Hon'ble Governor J&K Shri K.Viiav Kumar and Shri K.K. Sharma laid wreaths on the mortal remains of the martyred officer. Senior officers of the Police, Paramilitary forces, Army and Civil administration also paid their tributes to the martyred SHO. Paying their homage to the martyr, the advisors lauded his services for the nation. Principal Secretary Home J&K Shri Shaleen Kabra, DGP J&K Shri Dilbag Singh-IPS, Additional Director General of Police Dr. B. Srinivas, IGP Kashmir Shri S.P Pani-IPS, Divisional Commissioner Kashmir Shri Baseer Ahmad Khan-IAS and Deputy Commissioner Srinagar Dr. Shahid Iqbal Choudhary-IAS also laid floral wreaths on the mortal remains, paying tribute to the martyr for his supreme sacrifices.

# 14th Central Police Welfare Committee Meeting held

A number of decisions taken for the welfare of J&K Police personnel



Jammu & Kashmir Police organized 14th Central Police Welfare Committee Meeting on June 13, 2019 at PHQ J&K Srinagar. The meeting was chaired by Shri Dilbag Singh-IPS Director General of Police J&K. The meeting was attended by Addl. Directors General of Police Shri B. Srinivas-IPS, Shri A.K Choudhary-IPS, Shri A.G Mir -IPS, Shri Munir Ahmad Khan-IPS, Inspectors General of Police Shri S.D. Singh -IPS, Shri Danesh Rana-IPS, Shri J.P Singh-IPS, Shri Vijay Kumar-IPS, Shri Alok Kumar-IPS, Shri Surinder Gupta- IPS and Shri Afadul-Muitaba-IPS. Besides Senior Officers of the department. representatives from all the units / Districts of the department participated in the meeting and put their views and suggestions for the introduction and strengthening of different welfare measures.

During the meeting various decisions were taken after threadbare discussions on the relevant issues. The landmark decisions taken during the meeting are enumerated as under:

1. Special Welfare Relief has been enhanced from Rs.14 lakh to Rs.19 lakh. In this context J&K Police welfare fund rule No. 3 (a-ii) has also been amended vide PHQ order No. 2471 of 2019 dated 03.07.2019.

- 2. Provision of Spectacle relief has been abolished.
- 3. Meritorious scholarship to the wards of Gazetted officers of J&K Police shall also be admissible as per scales in vogue. The provision shall be applicable to the wards, who qualify the relevant classes with desired percentage after 13.06.2019. In this context J&K Police welfare fund rule 3(d-i) has been amended vide PHQ order No.2471 of 2019 dated 03.07.2019.
- 4. The condition of taping of GPF before availing of welfare loan is waived off for life terminal treatment claims. PHQ J&K has accordingly amended rule 3 (e) of J&K Police welfare fund rules.
- 5. The financial powers of various welfare committees for sanctioning of welfare loan have been enhanced. J&K Police welfare fund rule 3 (f) has also been amended vide PHQ order No. 2471 of 2019 dated 03.07.2019. As per the amendments, Central level committee can now sanction welfare loan of Rs.5 lakh instead of existing Rs.1,00,000/-. Zonal level committee can sanction welfare loan of Rs.1,00,000/-, Range level committee can sanction welfare loan of

- Rs.75,000/- instead of existing Rs.40,000/- and District /Unit level committees can sanction welfare loan of Rs.50,000/- instead of existing Rs.30,000/-.
- 6. Retirement gift has been enhanced from existing scale of Rs.60,000/- to Rs.75,000/-. In this context rule 3(i) of J&K Police welfare fund rule has also been amended vide PHQ order no. 2471 of 2019 dated 03.07.2019.
- 7. The monthly subscription scales towards various welfare funds have been enhanced from the month of June 2019. As a welfare gesture towards retired police personnel and SPOs, the members of regular force shall contribute Rs.40/- (Rs.20/- each towards retired police welfare fund and SPOs contributory fund). As per the revised scale DIG and above shall contribute a total of Rs.840/- GOs Rs.640/-, NGOs Rs.540/-, Ors Rs.490/ -, Foll / N.O Rs.395/- and SPOs Rs.100/ - towards monthly subscription of various welfare funds of J&K Police.
- 8. Subscription towards J&K Retired Policemen welfare fund has been enhanced from Rs.20/- to 40/- and Rs.15/- to 35/- for NGOs above and other Ranks respectively.

- 9. The scholarship for the wards of Martyr SPOs shall be available on the following scales as applicable to wards of Police Martyrs from academic session 2019 onwards, debt able to Police Pariwar Fund:
  - a. The scholarship to the wards of Martyr SPOs studying upto 5<sup>th</sup> Primary shall be given @ Rs.2400/ - per child per annum.
  - b. The scholarship to the wards of Martyr SPOs studying in class 6<sup>th</sup> upto 10<sup>th</sup> shall be given @ Rs.6000/
     per child per annum.
  - c. The scholarship to the wards of Martyr SPOs studying in class 11<sup>th</sup> upto Graduation or doing Diploma in technical courses shall be given Rs.10,000/- per child per annum.
  - d. The scholarship to the wards of

- Martyr SPOs doing technical courses of four years & above shall be given Rs.12,000/- per child per annum.
- e. The scholarship to the wards of Martyr SPOs doing PG or equivalent courses subject to one stream only shall be given Rs.12,000/- per child per annum and
- f. The scholarship to the wards of Martyr SPOs doing MD /M. Tech / PHD or equivalent courses shall be given Rs.15,000/- per child per annum.
- g. The relevant additions have been made to the J&K Police welfare fund rules vide PHQ order No.2471 of 2019 dated 03.07.2019.
- 10. The provision of relief has been enhanced from Rs.1,00,000/-

- upto Rs.1,50,000/- in respect of SPOs seriously injured in L&O duties in exceptional cases.
- 11. Provision of upto Rs 50,000/out of Police pariwar fund/ unit welfare
  fund has been introduced with
  immediate effect for Bara Khana on
  special occasions, exclusively to boost
  the morale of Jawans subject to
  approval from PHQ.
- 12. Financial aid for marriage of daughters of Police martyrs including SPOs out of Police Pariwar Fund has been enhanced from existing Rs.25,000/- to Rs.50,000/-.
- 13. Financial assistance in respect of SPOs including their dependents suffering from life terminal disease has been enhanced from Rs.25,000/- to Rs.50,000/-.

# PHQ Sanctions/ releases Rs.40,84,08,898/- in favour of Police personnel/ NOKs of Police Martyrs & Retired Police Personnel under various welfare schemes of J&K Police

During the first seven months of the current year, Police Headquarters J&K sanctioned and released an amount of Rs.40,84,08,898/- (Rupees Forty core Eighty four lakh Eight thousand Eight hundred and Ninety Eight only) in favour of NOKs of Police Martyrs, serving and retire police personnel under various welfare schemes of J&K Police. 
# Samba Police works out sensational kidnapping case

On May 06, 2019 Rtd. Honourary Captain Joginder Paul Sharma of Dasal Meen Sarkar Tehsil Bari Brahmana, Samba lodged a verbal report at P/S Bari Brahmana that his son namely Anirudh Sadhotra age 10/ 11 years, student of 5<sup>th</sup> class in Army Public School Kalu Chak Jammu was kidnapped by some unknown persons near Dassal, Bari-Brahmana when he was on his way to home after deboarding from school Bus. He also informed the Police that the kidnapper made a call to him and demanded ransom of Rs.01 Crore in lieu of release of his son.

On this, a Case FIR No. 61/2019 U/S 364 RPC was registered at Police Station Bari Brahmana and massive intelligence gathering efforts were undertaken under the close guidance and supervision of SSP Samba Dr. Koshal Sharma. Based on the leads collected, manhunt was launched to trace and recover the kidnapped child.

Sensing the seriousness of the case and the imminent threat to the child, SSP Samba constituted different Police teams and deployed them to various suspected locations viz Ramban, Gool, Doda, Kishtwar, Panchari, Udhampur, Katra as well as in the neighbouring States of Punjab, Himachal Pradesh, Chandigarh, New Delhi and Uttrakhand.

During the investigation and manhunt launched by Samba Police to trace the child & arrest kidnapers, the sequence of events which came to light in the said Kidnapping case are that one Sanjay Kumar of Gundna, Doda hired a room in the house of complainant (Retired Army Captain) on 25.03.2019 and stayed there upto 09.04.2019. He developed close intimacy with the land lord and his family and also managed to guess

financial position of his land lord who had recently retired as Army Captain. Guessing the potential of paying capacity of his landlord, the tenant Sanjay hatched a criminal conspiracy with his accomplices namely (1) Dheeraj (2) Blaith @ Amrit (3) Balbir @ Veer (4) Angrez Singh (5) Dheeraj-II and other associates. Thereafter, on 01.05.2019, tenant Sanjay & his accomplices purchased an old Car Maruti 800 from a private repair shop and got it notarized in the name of one of the accused namely Balbir Singh @ Veer. Then on 05.05.2019 they hired two room set accommodation at Rajpur Koular on verbal agreement of monthly rent of Rs.5000/- per month and paid Rs.2500/- as advance amount to the landlady. On 06.05.2019 at about 2.30 pm Sanjay and his accomplices (Balbir, Blaith @ Amrit and Dheeraj) kidnapped the child from Dassal, Bari-Brahmana when he was on way to home after de-boarding from school Bus they took the boy to the

rented house at Rajpur Koular by the same Maruti 800 car which they purchased on 01.05.2019. The child was confined in the rented house. One of the accused Balbir @ Veer stayed with the child in the rented house and others moved away from there. Meanwhile, Blaith @ Amrit boarded a bus from highway for Amritsar and made a call to the father of child on reaching near NHW Jakh. He confirmed him (Father of the child) kidnapping of his child and asked for ransom, and then proceeded to Amritsar. Meanwhile Dheeraj and Sanjay abandoned the vehicle used in kidnapping, in Karan Bagh area of Jammu and after providing food to Balbir @ Veer in the evening stayed in a hotel in bus stand area of Jammu. On 07.05.2019 afternoon, Blaith @ Amrit started calling on phone number of father of child and again demanded ransom in lieu of release of the kidnapped child. Then, under a properly planned strategy, Police party

in civvies along with the father of the child negotiated with the caller for the release of kidnapped child, and finally it was agreed to handed over the ransom to another party as directed by Blaith @ Amrit from Amritsar, Punjab. Thereafter the police party alongwith father of kidnapped child went to Tara road ahead of Nandhini where the bag containing money (infact a decoy bag prepared by police) was to be handed over to the other accomplice of caller as per negotiation. When the decoy bag was kept at the place directed by the caller, two persons came in a Tavera vehicle and picked up the bag. The Police party in civvies watching all these activities from different points intercepted the Tavera at a distance and let the inmates of the vehicle go after ascertaining their identity as Dheerai-II and Angrez Singh R/o Muttal. Udhampur. They however were kept under constant surveillance by Police parties in civvies. Thereafter, while negotiating, Blaith @ Amrit told to father

of the kidnapped child that child will be handed over in the evening after receipt of that bag. On the other hand, Police party at Tikri shadowed Angrez Singh and Dheeraj, who suspecting something wrong fled away towards Jungle Gali, Udhampur alongwith bag. Finally, on 08.05.2019 early in the morning, Balbir Singh @ Veer sensing large scale movement of Police in the area of Rajpur Koular, fled away from the spot leaving behind the child alone on one of the road in the area where the child came to be spotted and recovered by police. After the recovery of child, massive search was launched to capture the accused persons. Police parties raided different locations inside as well as outside the state and number of suspects were rounded up. interrogated and finally, 06 accused persons involved in the kidnapping of 11 years old Anirudh were arrested and 2 vehicles involved in crime (Maruti 800 No. JK02M-2660 and Tavera No. JK14D-4658) seized. Sanjay Kumar S/

o Bassi Ram R/o Gundna, Doda who was the previous tenant of the complainant and mastermind of this kidnapping, is however still at large but Samba Police is hopeful to arrest him soon and put him behind the bars.

Director General of Police J&K Shri Dilbag Singh IPS highly appreciated the professional capability and result oriented planning of SSP Samba Dr. Koshal Sharma, which brought to fruition the efforts put in by police teams. He sanctioned handsome cash rewards alongwith Commendation Certificates Class-I in favour of each member of the Police parties for their hard work and professional skills displayed by them in working out case FIR No.61/2019 U/S 364 RPC of P/S Bari Brahmna in which a minor student kidnapped for Rs.1 Crore ransom has been recovered unharmed and kidnappers identified/ arrested by the police.

## Rare act of honesty by GRP Katra

On May 24, 2019, a police party headed by SHO Police Station GRP Katra recovered a unattended Bag in Hemkunt Express at Railway Station Katra. After a lot of efforts the SHO identified and located the owner of the

# CRIME SCENE MANAGEMENT AND CHALLENGES TO DNA EVIDENCES

The author has done Ph.D. in Cytogenetics and has qualified Forensic Aptitude and Caliber Test (FACT)-2018. He has authored and co-authored various research/review papers/ articles in different international and national journals.

Any type of crime creates a crime scene, and as a forensic scientist it becomes very important to go deep in to the nitty-gritty of the crime scene. The place of occurrence, if properly managed, is going to determine the future of a criminal case. Identifying and at the same time appreciating the value of a particular physical evidence, is probably the most important factor in crime scene investigation and further processing. Therefore, it becomes very important that the crime scene investigator or the forensic scientist must have a comprehensive knowledge and exposure to all the fields that can play a role in the justice delivery system. Now, what expertise and exposure the crime scene investigator must possess, depends primarily upon the possible nature of physical evidences present at the crime scene. The variety of physical evidences present at the crime scene intern depends on the type of the crime committed. Therefore, a sharp crime scene investigator will try to include and exclude various physical evidences, depending on the relevance and irrelevance of these evidences in a particular case. Care has to be taken that no potent physical evidence should be skipped and irrelevant and unnecessary and extravagant items are not collected to avoid false leads. An idea of all the physical evidences, whether within or outside the crime scene demarcation will play a crucial role and hence need to be documented and preserved for future analysis. In a murder case, for example, the possible physical evidences that the investigator should

look for may include; weapon of offence, fingerprints on the weapon of offence or any other item which logically appears to have been touched by the perpetrator, foot prints, and types of injuries on the victim. Similarly, in a rape case the choice of physical evidences will shift a different way and depends on the perception and correlation power of the crime scene investigator. In this case the investigator will look for semen stains, touch DNA on the body parts of the victim, tissue, blood, etc. underneath the nails of the victim, so on and so forth. Thus it becomes very important that the crime scene investigator should have the expert knowledge of all the potent physical evidences present at the crime scene. The physical evidences that are almost every time the integral part of every crime scene include- soil particles, plant material, micro biome, etc. The type of material, time of deposition and uniqueness is morphological and anatomical characters are to be appreciated and evaluated by the investigator and at the same time comparing with reference sample from the area will definitely give new leads to the case. These evidences will also tell us whether the scene of crime is primary or secondary in nature. Studying the morphology and anatomy of plant material or pollen grains deposited on the shoes of the victim are going to change the fate of the case exploiting the principal of uniqueness of characters at the species as well as variety level. A piece of land that has been disturbed will follow a strict pattern of re-colonization called succession. In areas like

shallow grave sites, the primary colonizers are grasses followed by small shrubs and then trees. Depending upon the sun light/shade, soil conditions and water content, an estimate of time of death in these sites can be made through assessment of plant growth [1]. Estimate of time of death can also be made by forensic botany through pollen analysis [2, 3]. In an insurance fraud case, a young man damaged his hand and made a claim for insurance, for being a victim of robbery. During investigation, some grass fragments where found wrapped in a bloody newspaper. After searching the area, the location was traced where his hand was severed by comparing the plant material growing in the area with that of the plant material wrapped in the newspaper. Later on he confessed that he had used this plant material for covering his arm while getting back to his vehicle [1]. Therefore, it is immensely important that the crime scene investigator be a professional to the extent that he doesn't miss any potential physical evidence that creates a link between the crime scene and the perpetrators of crime or the victim. A person, who has lost his power of smell, cannot appreciate the fragrance of a delicious food prepared in the kitchen. In the same manner a crime scene investigator who does not have the idea of the potential and the reliability of a plant trace, or for the sake of discussion, any other material in and around the crime scene, seldom does he try to document and preserve the trace evidences and hence miss out the chance to link crime with the criminal.

#### Challenges to DNA evidences:




Fig. 1: In this figure the two heterozygous parents have 7, 9 (male) and 8, 11 (female) combinations. The off springs have a chance of getting four different combinations as [7, 8], [7, 11], [9, 8], [9, 11] and the probability of getting a repeated combination for any of the children will be one of four at one locus. This is repeated for all the loci and as accumulative effect there is a chance of one in over 6 million.

Deoxyribonucleic acid (DNA), is a unique bio molecule as far as its discriminatory power is concerned. This is due to its high combinational

potential and greater stability due to inter base hydrogen bonding and base stacking interactions. This makes DNA wonderful forensic evidence which can be used even after thousands of years of preservation. A large number of cases have been solved using DNA evidence since its essence in the year 1984, by Sir Alec Jeffrey. But, there is also some serious drawback even to this highly sophisticated technique of DNA profiling. DNA admissibility has been challenged in courts questioning the genetic issues, procedural/ technical issues, result interpretation, statistics, contamination, etc. [4]. Leaving other issues aside, genetic issues in the form monozygotic identical twins and full siblings pose a serious challenge to the field [5]. As far as the siblings are concerned we know that an offspring receives two alleles, one from the biological father and the other from biological mother. Let us assume at locus "A" the father is heterozygous having "7" and "9" alleles while the mother being heterozygous has "8" and "11". During recombination the probability that the two children will have the same combination of alleles can be drawn using probability ratios as given in the Fig. 1. The probability will be generated for all the loci studied (13 in this case). Since, every event is an independent one, the cumulative effect will be given as under;

 $\frac{1}{4} + \frac{1}{4} + \frac{1}$ 

That means it is possible that the two siblings have a chance of getting same alleles at one locus which is equal to one in four because there are four possible combinations at one locus of heterozygous parents. The probability will go on decreasing as we try to add more and more markers and for thirteen markers as stated above, there is a chance of repetition at all the

thirteen loci by a factor of one in 6718864. It can be very difficult to prove a criminal case before the court of law as far as the full siblings are concerned but may prove to be a lead for establishing other facts.

During his deliberations on the topic, Dr. Bhan shared his view that general public perceive the administration as pro political executive and bureaucratic centric and this perception has to be erased by the deliverance to the public on the touch stone of fairness, transparency, accountability, putting decisions on public domain and by imbibing the principles of ethics, values, integrity, honesty and morals. He stressed upon the officers not to get influenced by religion and caste, not to misuse the discretionary powers, always be apolitical, to respect merit and deliver the public service in time. He advised that all our acts must be "Citizen Centric" always and every time.

Dr. Bhan impressed that the General of J&K Police delivered lecture Administration should reverse from "Nexus Model" to "Citizen-Centric Model" of administration and advised the trainee officers to always make a

distinction between good and evil, between right and wrong and between what is virtuous and non virtuous and advised that systematic changes hold the key and to leverage on technology to promote transparency.

Dr. Ashok Bhan presented to the trainee officers the citizen centric model of administration and impressed upon them to follow this model over nexus model. He advised the trainee officers and staff of SKPA Udhampur to train themselves and muster courage to say 'No' to unethical orders and try not to be in conflict with the environment.

In the end, he exhorted the trainees that before taking any decision always ask these question to yourself first that as to whether the decision that is being taken by you is in public interest?, Whether the decision has been taken without fear or favour?. Will the decision benefit the needy irrespective of his/her socio religious background?, Is the decision without any selfish motive?. If you get an affirmative answer to this then it can be said to be the right decision, Dr. Bhan added.

Earlier, Director SKPA Udhampur Shri Mohammad Sulaiman Salaria. Addl. DGP welcomed Dr. Ashok Bhan and briefed him about the functioning of the Police Academy Udhampur.

# Safety and Security of Senior Citizens

As law enforcing agency the Police has been entrusted with multifarious duties including prevention and detection of crime besides maintenance of law & order. Apart from this, in the present day by day increase of crime, the safety and security of senior sect of the society i.e. safety and security of senior citizens is of utmost importance. There are multiple factors which lead to requirement of such measures which required to be discussed and addressed. The causes which are instrumental into the breach of safety and security of senior citizens and its remedial measures can be discussed under following heads: -

- The common causes leading to need for security, safety and awareness of senior citizens.
- 2. Remedial measures including role of police as well as legal remedies.

These points are discussed in detail below: -

- The common causes leading to need for security, safety and awareness of senior citizens.
- Main and common causes leading to breach of safety and security of senior citizens.
- Disintegration of Joint Family System.
- Migration of younger generation for job opportunities.
- Incidents of exploitation of elderly persons by family members and unscrupulous elements.
- Sensational crimes by known persons, domestic servants, helpers, plumbers etc.
- II. Need and awareness amongst senior citizens.
- Senior citizens need to be made

- aware about their safety and security.
- Need for registering senior citizens with Police.
- Senior citizens associations as well as RWAs(Resident welfare Associations) can play important role in this regard.
- Awareness can be made by way of advertizing the steps for safety and security in print media from time to time and also by making appeal to senior citizens to get them registered.

#### III. Registration of senior citizens.

The cells can be created / established for registration of senior citizens who can be categorized as: -

- Citizens of 60 years or above residing alone or with spouse.
- Citizens 60 years or above though living with family but remain alone for a long period during day time as their children and their spouse go for work.

#### IV. Mode of registration:-

For purposeful registration the steps required are as under:-

- a. By way of personal visit; this can be done by collecting the lists of such senior citizens through beat Constables or even by other means feasible as per the locality.
- b. By receiving information through fax/ telephone and also online for which appeals can be made and telephone numbers etc be communicated by meeting personally or by way of advertisements in print and electronic media.
- For registration even special drives/ melas can be launched from time

to time.

# V. Maintenance of record of such citizens.

For this it should be ensured that the registered number of senior citizens are diarized properly and lists are prepared area wise/ Police Station wise so as to maintain a proper record of senior citizens category wise residing in that particular area.

- VI. Steps required to ensure the safety and security of senior citizens.
- a. Visits to registered senior citizens.
- It should be ensured that regular visits are paid to such senior citizens residing in any area. For this a beat officer can made it a point to visit such senior citizens at least once in a week in different areas. The concerned SHO can spare some time and visit at fortnight intervals in different areas. Similarly, the senior officers of senior citizens cell or other supervisory officers can also pay visits regularly.

During such visits the following points should be kept in mind and action taken accordingly.

- There should be security audit of their residential premises in a comprehensive manner. Their houses should be checked to see whether security equipment/ gadgets like home alarm, CCTVs, door camera, magic eye and door safety chains etc are installed and functional. Also if there are required strong iron grills for windows doors etc.
- It should be checked if the verification of servants, tenants and other service providers has been got done, if not the same should be got done.

- The senior citizens should be advised to plug/correct any such security defects to enhance their physical security.
- Discussion should be held about their safety and security needs.
- There should be creative awareness about the crime trends and precautions to be taken.

Besides, paying the visits a constant contact can be maintained with senior citizens by communication means like telephone/ messenger apps like WhatsApp, so that it is not accessible by general public.

### VII. Security tips to senior citizens.

While visiting the senior citizens the following security tips/ advisories can be given to senior citizens.

- Keep vital telephone numbers handy for emergency.
- Inform nearest PCR van and neighbours if they are suspicious of someone.
- Keep regular link with neighbour and (RWAs)Residents Welfare Associations.
- Verify the antecedents of the strangers before giving them entry.
- Go out in a group for morning/ evening walk.
- Keep valuables out of the sight of domestic help.
- Keep an eye on visitors of their servants.
- VIII. In order to effectively implement the measures for safety and security of senior citizens there should be institutionalized mechanism for safety and security of senior citizens. This may include constitution of different committees/ cells as under: -

#### ♦ Senior Citizens Security Cell.

Such cells can be established at state level or at zonal levels being monitored by senior officers and the purpose of such cells stands defined in the afore-mentioned paras. The complaints received at the cell shall be forwarded and sent to concerned districts for taking necessary action and also to monitor and follow up the action taken.

#### ♦ State level advisory body.

State level advisory body with a senior officer at least an IGP from PHQ or otherwise as deemed fit should act as chairman. District Police chief heads and at least one senior citizen from each district should be incorporated as members. The role of state level advisory body which should meet at least after every six months should be held to discuss steps and measures for safety and security of senior citizens and also to monitor and take stock of the working of other subordinate formations for the purpose.

## District level advisory body for safety and security of senior citizens.

Such advisory bodies shall be headed by district police chief as chairman and other gazetted/ non gazetted officers as well as at least one senior citizen from the jurisdiction of each Police Station as members. Such advisory body should meet at least once in three months and its role shall be to discuss steps and measures for safety and security of senior citizens in that particular district.

#### Volunteers Committees at Police Station level.

In order to be in constant touch with the senior citizens besides the role of beat officer/ Constable and concerned SHOs, one or more volunteer committees should be established of volunteers amongst the civil society. Role of such volunteers shall be to maintain regular contact with senior citizens and police. Such committees should meet at least once in a month.

Besides, the NGOs at state level as

well as national level can also play a vital role in ensuring the safety and security of senior citizens as they can come up to find out the causes for such neglect and fight for or take steps to eradicate the root causes which is eclipsing the moral values amongst the young generations and in our social lives. They can play a vital role by counselling in order to jolt the consciousness of youngers and invoke sense of respect and care for senior citizens and parents.

### Legal provisions.

The safety and security of senior citizens has been taken care by the govt. by enacting legal provisions for the purpose. For this an act under the nomenclature "Maintenance and Welfare of Parents and Senior citizens Act, 2007" was enacted in 2007 by legislation at the initiative of ministry of Social Justice and Empowerment and after being passed by parliament of India received the assent of president of India on December 29, 2007 and was published in the gazette of India on December 31, 2007 making it a legal obligation for children heirs to provide maintenance to senior citizens and parents by monthly allowance. The maintenance includes provision for food, clothing, residence, medical attendance, treatment, welfare means to

provision of recreation and other amenities besides food and healthcare for senior citizens.

In case of neglect/ violation of the provisions by the children or legal heirs the senior citizens can claim their right and complain for enforcement of remedy of maintenance before the tribunal established for the purpose. The detailed procedure of filing application for such purpose the period involved and the penalty for non compliance of the provisions of the act/ directions of the tribunal have been discussed threadbare in the above referred act.

## Can EVM be Hacked/ Tampered

- It is not machine which becomes corrupt it is corrupt human which makes machine corrupt.
- EVM can not be hacked.
- Tampering by human is ruled out by fool proof security features of EVM and safe custody of EVMs and check, recheck and cross check at every chain of custody with further checks and balances under close observations/monitoring of ECI.

Ever since Electronic Voting Machines have been introduced there have been apprehensions that such device can be helpful to a particular party and can be tampered /hacked accordingly. The unawareness of general masses and particularly voters about this electronic device aggravated the issue. The election commission of India has started various awareness programme particularly SVEEP for educating people about participation in voting and awareness about the EVM.

In order to dispel the misgivings vis-a-vis EVM it is necessary to briefly understand the components of EVM in a layman's language.

EVM (Electronic Voting Machine) consists of two parts (Units): -

#### 1. Ballot Unit: -

It has a button against each candidate name and respective symbol. It facilitates voting by a voter through this labeled button. It is connected with another unit-control unit through cable.

#### 2. Control unit: -

It controls ballot unit; stores vote counts and displays result on LED display. It has 6 volt battery. It has its one time operating programme (OTP) which can not be changed. It is also known as Brain of the EVM.

It is pertinent to mention here that only two PSUS make EVMs -Bharat Electronic Limited (BEL) - Electronic Corporation of India (ECIL).

The EVM is specially designed with following security features for ensuring transparency and dispelling the apprehensions of any tampering/ fiddling.

- 1. EVM used here is a machine and not a computer peripheral. Every computer may be a machine but every machine may not be a computer.
- It is an offline standalone machine with no connectivity like WiFi, LiFi, and Bluetooth etc and thus can not communicate with any other device so question of hacking does not arise.
- The operating programme OTP is permanently etched on silicon chip at the time of manufacturing and can not be changed at all even by the manufacturer.
- EVM functions on the principle of "One person one vote" i.e a) It is not possible to vote more than once by pressing a button again and again. b) On one pressing of button, vote is recorded and machine gets locked.
- 5. To ensure more transparency one more device has been connected i.e **VVPAT** (Voters verifiable paper audit

which gives feedback/ Verifications to the voter that the vote goes to the correct candidate thus it is the second line of verifications to satisfy that EVM is not tampered. Even counting through VVPAT can clear doubts if any at the time of counting.

EVM tracking software/ encryption technology have made it more tampering proof.

#### Some suggestions for bringing more transparency: -

- Voters still may have doubt 1. that after sealing of EVM, tampering may occur till counting. To dispel this doubt if possible concerned in future may subject EVM data to hash value at the time of sealing after voting is over and that hash value be tallied with hash value of EVM before counting when seal is broken. This will ensure the safety and security of votes from the time of polling till counting.
- CCTV at polling stations at appropriate places may also be installed. Strict surveillance system 24x7 in strong rooms through CCTV with monitoring at control room and with mobile of CEO/ Observers as deem fit.
- 3. Sealing/ packing/ labelling and transportation with due care the same way as if digital evidence is

preserved sealed pack labelled and transported to the next destiny.

- 4. EVM has only one function i.e. votes and counts. No other function is possible. So awareness through SVEEP be made.
- 5. Anti-sabotage check in strong room to avoid magnetic field as electronic data may get effected/ lost by magnetic field.
- 6. Antecedents of staff deployed to prevent intervention of unscrupulous elements.
- 7. No person with any device like mobile etc. or data cable/ pendrive/ CD/ Alexa etc. be allowed in polling/ counting or strong room.
- 8. The staff on duty should not mix-up with public and arrangement for their meals be done at place of duty rather than any civilian arranging their meals or tea. This may help in maintaining discipline, secrecy and impartiality.
- 9. Instead of randomisation, every EVM be checked/demonstrated before actual voting at polling booth level to ensure accuracy before agents of all political parties. This exercise will infuse trust on EVM functioning.
- 10. Video-graphy of polling without compromising secrecy and guideline of ECI.


