**Whereas**, in pursuance to the Hon'ble High Court directions passed in clubbed service writ petition Nos.3065/2010 titled Anita Sharma and other Vs State of J&K & others and 1620/2010 titled Shakti Pathak and others Vs State of J&K followed by the Govt. Home Department directions issued vide latter Nos. Home/GAZ/SWP/06/2013 dated 01-04-2013, 2555 dated 14-05-2013, 11-03-2014 and 28-03-2014, a final redrawn seniority list of Inspectors (Executive/ Armed/Auxiliary Police) as on 31-12-1993 was issued in terms of PHQ order No. 259 of 2015 dated 30-01-2015 and forwarded to the Govt. Home Department J&K for further course of action.

**Whereas**, a proposal for regularization of DySSP was forwarded by PHQ to Govt. Home Department vide communication No.GZ/G-13/Regularization/DySP/2018 dated 15-05-2019.

**Whereas**, in response, Home department J&K vide above quoted references has intimated that the redrawn seniority list of Inspectors issued vide order No. 259 fo 2015 dated 30-01-2015 is not sufficient to consider the proposal in toto as such, directed to provide the list of Inspectors as per their seniority positions beyond Shri Shiv Kumar Khajuria (i.e the Inspector figuring last in the aforesaid seniority list) to facilitate the Home Department to process the proposal for regularization of DySSP.

**Whereas**, in pursuance to the directions of Home Department, a committee was constituted vide PHQ order

No.2364 of 2019 dated 25-06-2019 which, while revisiting the seniority lists of Inspectors issued earlier in the year 1998, 2004, 2010 and 2015 onwards in terms of PHQ order Nos. 3615 of 1998 dated 26-10-1998, 1980 of 2004 dated 06-07-2004, 1403 of 2010 dated 08-04-2010 and 3509 of 2015 dated 23-11-2015 with reference to the redrawn seniority list of Inspectors issued vide order No. 259 of 2015 dated 30-01-2015, found that some Inspectors were granted predicated effect in their promotion during past exercise. As a result the vacancies which had become available due to such promotions with antedated effect are carried forward and some of the officers who were promoted "Out-of-Turn" in Executive Cadre from time to time came to be adjusted against those vacancies. By virtue of this, date of promotion of few Inspectors promoted upto May 1997 got affected. However, date of promotion in respect of Inspectors belonging to reserved categories for such period has not been disturbed as they were granted promotion benefit earlier against the roster points of their respective categories.

**Whereas**, in light of the above, a tentative seniority list of Inspectors promoted/appointed from 01-01-1994 to 05-10-2016 was prepared and notified vide PHQ order No. 2679 of 2019 dated 12-07-2019 for the stakeholders through Police Website as well as daily news papers for obtaining objections, if any, with regard to the placement, DOB,DOP, categories, and other credentials within the stipulated period of (15) days from the date of issue.

**Whereas**, in response, following officers have represented with their representations as tabulated against each. These representations were examined threadbare by the Committee constituted vide PHQ order No.2364 of 2019 dated 25-06-2019 and disposed as under:-

However, prior to the enrolment of the subject, (07) SIs were granted promotion as Inspector and accordingly they have taken their position in the seniority list over and above the name of the subject in the seniority list of Inspector for which the officer had represented earlier also which was rejected and communicated vide this Hqrs letter No Pers/M-403/2000/50414 dated 19-07-2018.
15.	Sh Ab. Rashid Wani DySP	EXK901947	Represented that he was brought on promotion List-F-1999 among others, vide PHQ OB No 1565 of 1999 dated 26-04-1999 at S.No 81, among 70 officers were promoted as Inspector with immediate effect. Later 53 vacancies of Inspectors have accrued on 27 <sup>th</sup> of March, 2000 by way of promotion of equal number of Inspectors as DySsP and requested for his promotion from same date.	As per records, the DPC was conducted in the year 1999 which remained in force upto 31-12-1999. Again, in the year 2000, DPC was conducted in which the representee among others, was promoted as Inspector with effect from 19-08-2000. As such, his ground is not justified. However, he has filed SWP No 1645/2004 in the Court of Law which is Sub-judice .

Inspr Om Parkash	EXJ955634	A group of Inspectors direct recruited in 1995 figuring from 16 to 43 have submitted representations stating therein that they were enrolled in J&K Executive Police as SI in the year 1995 while-as their junior colleagues viz SIs of Armed Police Batch 1998 have been given promotion to the rank of Inspector and made senior to them.	The seniority of SIs of Executive/Armed Police is maintained separately at PHQ and APHQ level. Accordingly, their promotion to the rank of Inspector is effected on the basis of vacancies available in their Parent Cadres. As such, the plea put-forth by these officers was considered and rejected being devoid of merits.

Inspectors issued earlier vide PHQ order No. 259 of 2015 dated 30-01-2015 was awarded diesnon for the period of three years one month and 29 days vide Govt GAD OB no. 1332 of 2007 dated 19-11-2007. His date of promotion as Inspector would now be 20-08-1994 instead of 21-06-1991 as the officer has lost his seniority in the rank of Inspector due to diesnon. As such, the name of the officer is treated to be deleted from the seniority list of Inspectors issued vide order No. 259 of 2019 dated 30-01-2015 and accordingly placed in the instant seniority list at appropriate place in light of above referred Govt order.

**Whereas**, Insp. Sarnagat Singh No. 325/NGO and D.N.Panchi No. 11/NGO already figuring in the seniority lists of Inspectors issued in the year 1998 and 2004 vide order Nos. 3615 of 1998 dated. 26-10-1998 and 1980 of 2004 dated 06-07-2004 at S.No.02 and S.No. 12 respectively have inadvertently been dropped in the redrawn seniority list of Inspectors issued earlier vide PHQ order No. 259 of 2015 dated 30-01-2015, shall now figure at S.No. 4-A i.e below the name of Insp. Krishan Lal Sharma No. 811/NGO and at S.No. 320-A i.e above the name of Insp. Mohd Maqbool No.20/NGO in the said redrawn seniority list in order of their date of promotion as Inspector i.e 11-03-1983 and 01-05-1992 respectively.

**Whereas**, Insp. Ravi Kant No..931/NGO who was granted antedated effect to his date of appointment as Inspector with effect from 01-03-1992 in terms of PHQ order No. 4759 of 2018 dated 27-09-2018 on the directions of Hon'ble Court will now figure below Insp. Arjan Nath Raina No. 752/NGO in the redrawn seniority list of Inspector issued vide PHQ order No. 259 of 2015 dated 30-01-2015.

**Whereas**, Insp. Vijay Kumar Jamwal No. 4549/NGO who too has been granted ante dated effect in his promotion as Inspector with effect from 01-03-1992 vide PHQ order No. 2965 of 2019 dated 29-07-2019 on the same analogy of Shri Ravi Kant No.932/NGO. In order of seniority, he shall figure over and above Shri Ravi Kant No.932/NGO in the seniority list of Inspectors issued vide PHQ order No. 259 of 2015 dated 30-01-2015.
