Subject:- Pre-bid meeting held at Police Headquarters J&K Jammu on 16.03.2019 in connection with e-NIT No. 15 of 2019 dated 2.3.2019, floated for purchase of 05 Nos. BR Ambulances on 4x4 base vehicles.


As per contents of e-NIT no. 15 of 2019 dated 2.3.2019, a Pre-bid Conference was held at Police Headquarters J&K Jammu on 16.03.2019.

All the intending Tenderers are hereby notified about the outcome report of the Pre-bid Conference, **which is mentioned below.** The said outcome report of Pre-Bid meeting shall mutatis mutandis form part of the said e-NIT and deemed to be an amendment to the e-NIT wherever applicable. The other terms & conditions of the e-NIT shall remain unchanged.

1. **Delivery Period:-** The qualified tenderer shall have to deliver prototype BR Ambulance within 60 days after issuance of Supply Order and remaining 04 BR Ambulances within 150 days from the date of issue of Supply Order.
2. **Side Mine Blast:-** The qualified tenderer shall have to provide Certificate after delivery of vehicles that BR Ambulances shall withstand 'Side Mine Blast' as per BPR&D norms.
3. **Category of Ambulances/Seating arrangements:-** The Ambulances should be Type-C (Basic Life Support) Road Ambulances as per AIS-125 i.e. a vehicle suitably designed, equipped and capable of transporting adequate staff and treatment of patient(s) requiring non-invasive airway management/basis monitoring.
The patient compartment should carry Double Stretcher loading and should be well constructed to accommodate all medical devices (installed above 700 mm from floor level) as required in basis Life support besides proper Seating for adequate staff (2-3 personnel).
4. **Paint:-** The Ambulances are to be provided in white colour with red Cross sign.
5. **Fabrication Drawings:-** The intending Tenderers shall have to submit schematic drawings with tender offers and detailed drawings after placing Supply Order.

6. **Emission Norms:-** The base vehicles should be BS compliant as per present norms of Ministry of Road Transport & Highways GOI.
7. **CMVR trials to be conducted only if GVW of the vehicle exceeds:-** GVW-the recertification is only needed, if the weight exceeds the prescribed Limited.
